We help in obtaining export or re-export licenses and special comprehensive licenses from the Department of Commerce, the Office of Foreign Assets Control, and other U.S. Government agencies and assist them in identifying license exceptions. We also help clients with business issues such as compliance with the Committee on Foreign Investment in the United States (CFIUS) and with establishing Foreign Trade Zones. Nossaman has also helped obtain U.S. Customs and Border Protection letter rulings and approval of Foreign Trade Zones for in-transit cargo.

We have successfully defended clients accused of customs and export control violations (both civil and criminal), and helped them avoid potential customs duties and penalties, and obtain special licenses and exemptions for exporters.
