He has been lead counsel in over two dozen successful civil complex arbitrations, jury and bench trials, ranging from 2 to 12 weeks. Patrick has won precedent-setting jury verdicts and has agreeably negotiated high value settlements.

## EXPERIENCE

***LAEC, Inc. v. City of Los Angeles (2023).*** Lead trial counsel defending City in consolidated lawsuits arising out of long-term contract for equestrian center within Griffith Park. Case involved complex issues of commercial tenancy, extension and termination provisions, statute of limitations and the Tort Claims Act. After prevailing in Phase I of a bifurcated trial on all contested issues, remaining claims settled.

***Santa Clarita Valley Water Agency v. Whittaker (2022).*** Served as lead trial counsel in a three-week trial in Federal Court, successfully representing the Santa Clarita Valley Water Agency in a jury verdict and judgment of \$69 million for clean-up of perchlorate and VOC contamination in the Upper Santa Clara River basin. In addition to claims of negligence, public nuisance and private nuisance arising out of the subsurface intrusion of perchlorate and VOC contamination into the Agency's drinking-water wells, the Court also awarded investigation costs under CERCLA.

***The Federal Deposit Insurance Corporation as Receiver for R-G Premier Bank of Puerto Rico v. Galan-Alvarez, et al.*** Lead counsel in professional liability litigation arising out of the failure of a \$6 billion bank doing business in Puerto Rico and Florida. The litigation involved complicated issues of corporate governance, director oversight and alleged lending failures. The matter favorably resolved for payments from Defendants in excess of \$28 million, including over \$20 million in non-insurance, personal asset contributions.

**Orozco v. Conrad (2017).** Lead trial counsel for plaintiff on claims including fraud and coercion as to her commercial lease new landlord. The jury returned findings of fraud and a verdict of over \$2.1 million in punitive damages after a one-month trial.

**Federal Deposit Insurance Corp. v. Van Dellen et al.** (United States District Court, Central District of California 2012) Trial counsel for the FDIC in a month-long professional liability trial arising out of the failure of IndyMac Bank. The claims of negligence and breaches of fiduciary duty against former officers of the Bank centered on loan approvals related to large real estate developer loans. The 9-person jury returned a unanimous verdict on all claims, awarding damages of nearly \$169 million. The *National Law Journal* ranked the verdict as number 13 in its annual national "Top Verdicts" list. The verdict was also recognized by the *Daily Journal* in 2012 as having the most significant impact of any plaintiff's verdict in California and for being the second largest dollar verdict in the state.

**Securities and Exchange Commission v. Sabhlok et al.** Defended as lead trial counsel controller of publicly traded company (NASDAQ: EMBT) in action by SEC over claimed stock options backdating and resulting false SEC filings. Obtained defense verdict outcomes on all securities fraud claims after 3 week federal jury trial.

**Amtower v. Photon Dynamics, Inc. et al.** Successfully represented Photon Dynamics, Inc. in a 5-week jury trial. Plaintiff alleged federal and state law claims of securities fraud arising out of a stock-for-stock merger agreement and registration statement, claiming that the acquiring company misrepresented that shares would be freely transferable post merger. Plaintiff alleged that aspects of the acquiring company's insider trading policy breached the duties of good faith and candor. The jury returned verdicts for all defendants on all causes of action.

**FDIC v. Lent et al.** Represented FDIC as lead counsel in corporate governance and accounting fraud dispute stemming from a \$300 million bank failure following an internet issuance of credit cards. Negotiated successful settlements after the bank was placed into receivership.

**Mitsubishi Electric & Electronics v. Hughes Network Systems.** Served as lead plaintiff's counsel in breach of contract claims involving Hughes' Spaceway Program, a \$3.5 billion satellite communications system. The jury returned a 12-0 verdict in favor of our client, awarding damages for breach of contract and breach of the covenant of good faith and fair dealing.

**DiPirro v. Bondo Corporation.** Successfully served as lead trial counsel on a case of first impression, representing a manufacturer of automotive touch-up paint accused of violating Proposition 65. Won a defense verdict in trial court, subsequently affirmed by the Court of Appeal. The determination that no product warning was warranted based on the "average consumer" standard resulted in the first published appeal following a trial decision on Proposition 65.

**International Paper v. Affiliated FM.** Served as plaintiff's co-counsel on an insurance recovery action arising from the failure of 22 insurance carriers to defend and indemnify International Paper for damages paid in settlement of a national class action lawsuit involving hardboard siding. A San Francisco jury returned a verdict of \$383 million in favor of the client.

**In re Valley Land Investors I, L.P.** Assisted the secured lender to recover a \$17.5 million claim in a Sacramento-based real property development chapter 11 case.

**Ortner v. Thorn.** Served as lead counsel for defendant attorneys in jury trial on breach of fiduciary duty claim, resulting in defense verdict and recovery on cross-complaint.

**Selma Medical v. Gullian.** Served as lead trial counsel for the developer, Selma Medical Center, in successful American Arbitration Association (AAA) arbitration hearing and court enforcement arising out of real estate development under the Subdivision Map Act.

**Numerous private arbitrations.** Has served as lead counsel on many private arbitrations, including contractual disputes, peer review proceedings, and fee disputes.

**Confidential investigations.** Has represented witnesses and targets in government investigations, and has represented agencies conducting investigations.
